Research on Teaching Reform of Architectural Construction Course Based on Curriculum Ideology and Politics for Architecture Major

3. The current situation of curriculum ideological and political teaching in architecture courses in colleges and universities

Architecture is an integrated product of the three systems of human, environment and engineering technology. It not only contains the technical elements of architectural engineering, but also permeates the humanistic elements such as aesthetics and ethics and social elements such as economy, management and law. In recent years, the high standard demand for architectural professionals has prompted the unprecedented attention to the core value of architectural education. The education of architecture specialty shoulders the important mission of cultivating innovative and entrepreneurial talents for urban and rural construction. The ideological and political education of architecture specialty courses is an important guarantee to realize knowledge teaching and value guidance in professional teaching. At present, there are still many deficiencies in the understanding and development of the ideological and political education of the architecture major courses in China's higher education, which is not conducive to stimulating students' sense of mission to participate in China's new urbanization, and is not conducive to stimulating students to realize social values in their career.

4. Teaching reform and innovation strategy of architectural Construction based on curriculum ideology and politics

4.1. Combine knowledge teaching with belief shaping to reform classroom teaching methods

Whether college students majoring in architecture can establish a scientific belief and correctly understand their responsibilities and historical missions in urban and rural construction is not only related to their healthy growth, but also affects the future construction and

4.2. Combine comprehensive teaching with special lectures to activate and enrich teaching methods

4.3. Combining theoretical learning with practical application and going out of classroom onsite teaching

The combination of theoretical learning and practical application of architectural engineering design and construction is the basic principle of the teaching of Architectural Construction. For students, it is not easy to understand their structure and practice only by drawing, writing and teacher's description. It is often the theory study that is very serious, and I am at a loss in the specific design.

The combination of theoretical learning and practical application in the teaching of Architectural Construction, actually means that the contents involved in specific chapters should not only be explained to students from the aspects of structural design principles and application conditions, but also from the aspects of theoretical basis and practical principles, so as to explain practice with theory and confirm theory with practice. If on-site teaching, visual display teaching in building construction laboratory, building construction model building training and other practical application teaching links are set up in the course, not only can students' professional foundation be comprehensively improved, but also with the help of on-site teaching, craftsmanship skills can be taught, craftsmanship spirit can be spread, ideological and political teaching of the course can be infiltrated into students' hearts with success, and students can be helped to shape a correct world outlook, outlook on life, and values.

4.4. Combination of online edification and offline teaching, integration and optimization of teaching mode

With the rapid popularization of the Internet, contemporary college students are almost all online, daily and everywhere. This requires teachers to carry out ideological and political innovation in the teaching of Architectural Construction, establish network thinking and use the convenience brought by information technology. Cleverly hide teaching and learning into the transmission of network information, and enhance students' acceptance, identification and acquisition of ideological and political education.

On the one hand, in addition to using online course learning sites to enrich learning resources, we can also use the educational functions of new media network platforms such as Tiktok, Kwai, and micro film to specifically explain hot and difficult issues in teaching in a form that students like to see and hear, so as to stimulate students' interest in learning. On the other hand, in addition to using online course sites to set up homework and discussion, we can also use new media platforms such as WeChat and Weibo, which are widely used by students, to publish learning tasks and set discussion topics, so as to enhance the appeal and appeal of ideological and political elements, make ideological and political education come alive, and truly achieve infiltration and edification education, which is ubiquitous and moistens things silently.

5. Implementation path of architectural Construction teaching reform based on curriculum ideology and politics

5.1. In combination with the characteristics of Architectural Construction, deeply explore the ideological and political education elements of the curriculum

In a broad sense, ideological and political elements include scientific world outlook, outlook on life, values and morality, as well as mental health. The ideological and political education of Architectural Construction should focus on the overall development law of the architecture specialty. 5.2. Give full play to the role of the main channel of the classroom and realize the imperceptible influence of ideological and political guidance

5.3. Increase the learning strength of teaching research and strengthen the overall improvement of teachers' comprehensive cultivation
