

# *Reflections on Integrity Management in Logistics Administration Work at Private Universities*

(8) Strengthening Assessment and Evaluation Systems: Assessment and evaluation systems are assessments and evaluations of various works at the school. ### **3. Strengthening Integrity Education**

(7) Conducting Specialized Training: The logistics management department of the school conducts special training for the hidden dangers and risks existing in the work to improve the ability of

employees to identify and prevent corruption.

#### 4. Strengthening Integrity Supervision
