Most residents are unemployed at home and are prone to anxiety. Social workers accompany residents to chat or take them to exercise at home to pass on positive thoughts to them.

4.1.2. Resource links

In order to better meet the needs of community residents, social workers need to coordinate multiple resources to solve their problems and needs [4]. At the height of the epidemic, during the Spring Festival last year, there was already a severe shortage of some protective materials. Social workers need to timely investigate the quantity of missing materials, coordinate with government departments for feedback, and link social organizations, public welfare institutions, foundations, enterprises and other social resources to provide medical materials for volunteers, disinfection materials and basic living materials for community residents.

4.1.3. Initiate a mobilization

Social workers in Enquan Community of Jinan City reported the latest and most complete data information to the district headquarters every day, immediately informed all communities for follow-up investigation, registration and registration, and timely fed back the real situation to all departments for re-comparison, to ensure detailed information and adequate prevention and control. The "Pneumonia caused by Novel Coronavirus Questionnaire" and several wechat groups and QR codes were designed to ensure the most authentic and effective data. Through the background management system of Jiedaoquan Xinwish mini program, recruitment orders for epidemic prevention volunteers were issued in the micro volunteer column in the name of each community. When we encounter difficulties, especially public health events such as the epidemic, we Chinese people will be more united in our faith. When social work organizations recruit volunteers, they have the same original intention, which makes it easier for community members to participate in the fight against the epidemic.

4.2. Deficiencies in social work

4.2.1. Staff turnover problem

The main reason for staff turnover in social work institutions is the low salary and poor treatment in the social work industry. It is obvious that inland northern cities, wages are not high, the eastern coastal social work development is relatively good, wages are relatively considerable. Many cities don't even have social work agencies. Maslow's Hierarchy of Needs theory puts forward five hierarchies of needs, the most basic of which is physiological needs. Many social workers' salaries only meet the needs of food and clothing, and it is a problem for many male students to support their families [5]. In today's society, people are pursuing a higher quality of life, so such salary cannot satisfy people's desire. As a result, many people graduate from college and do not go into the profession. 4.2. 4.2.2. Professional competence of social workers

In recent years, many places have started to build social work stations, which can promote the professional development of social work on the one hand and provide employment on the other hand. However, many of them are not professional social workers, some of them love social work and devote themselves to this industry, and some of them are volunteers. Professional social workers should have professional training. Have professional knowledge, master professional skills. Many people in the epidemic need emotional counseling and psychological comfort, and professional social workers with empathy and other skills can provide guidance to them. But others don't have that, and therefore don't bring the advantages of professional social work to the workplace.

4.2.3. Acceptability of social work

At present, most people's understanding of social work is still insufficient. Many people do not know what social work is. Most people equate social workers with volunteers. 5.4. Cultivate the public's enthusiasm for participating in social practice

In terms of the public, for the community residents, we can cultivate the public's sense of participation in voluntary service.
