

Innovation of Student Management Mode in Public Security Colleges Based on Professional Ethics Education

Abstract: With the development of society, higher vocational education is developing vigorously. The policing management of public security university is the same origin as the militarization management we are familiar with, but it is different from the militarization management and the policing management of public security organs.

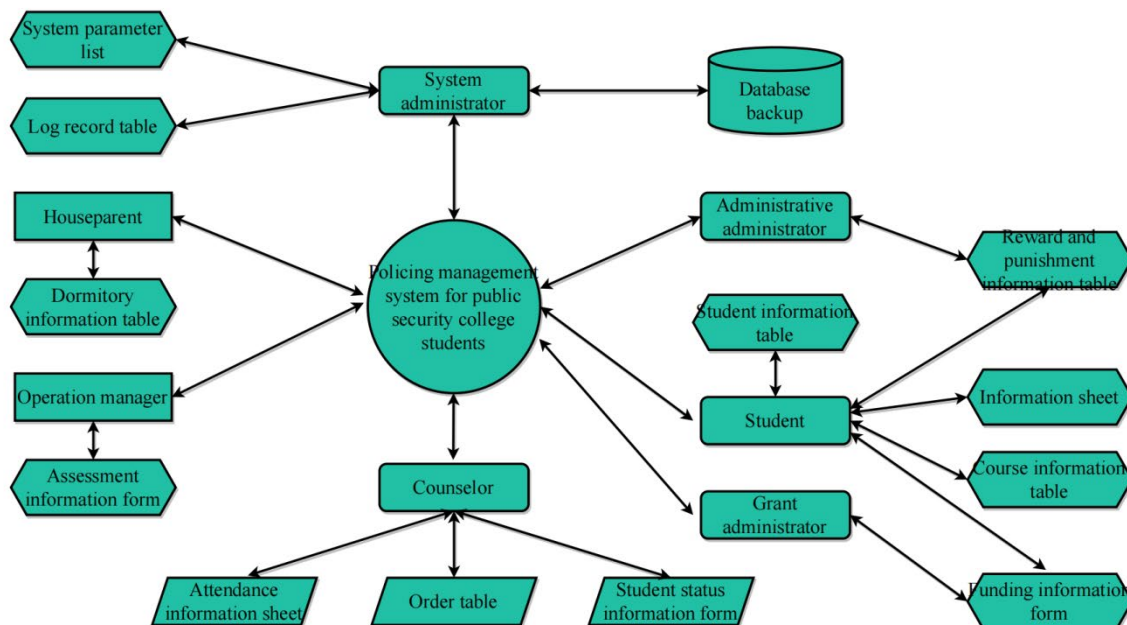


Figure 1 System Top Level Data Flow Chart

System administrators are mainly responsible for system management, including the design of system parameters, database backup and restore, and log management. Dormitory administrators are responsible for dormitory allocation, dormitory hygiene inspection, dormitory safety and other operations; The behavior administrator is responsible for the management of student behavior assessment; Counselors are responsible for students' academic study management, daily training management, attendance management, order management and other operations; The administrator is responsible for the students' reward and punishment management; The financial aid administrator is responsible for reviewing students' financial aid applications, granting financial aid and other related operations; Students can choose courses, check their grades, apply for financial aid, apply for scholarships, etc. As shown in Figure 1.

Third, teachers should be encouraged to study by themselves.

With the acceleration of the "rate of knowledge obsolescence", modern teachers must go out of the misunderstanding of one-time education, consciously carry out secondary education, and establish the concept of lifelong learning. Through party and league activities, daily ideological education courses, campus cultural life to carry out ideological enlightenment; Infiltrate through public security specialized courses; Infection through enrollment education and advanced deeds of outstanding graduates; Practice through social practice and graduate practice, investigation and research; Cultivate by optimizing the school education environment, and run through professional

ethics education in an all-round way. In the implementation steps, students should be educated in professional ethics in different stages to solve different problems in different stages. In the first stage, let students understand and love the public security work, mainly focusing on the admission education of freshmen. The second stage is to strengthen the education of professional ideals and ethics. Adhere to the assessment criteria based on actual performance, establish an objective and fair evaluation system, select and employ the talents who have the ability to do ideological and political work for college students to corresponding posts, and implement strict post employment assessment, so that they can rise and fall. Only in this way can we ensure the vitality of college counselors. The system management module is mainly composed of three sub modules: system parameter management, database management and log management. The specific module design is shown below. For those who fail to pass the examination, in addition to some education, some measures should be taken, such as low employment or dismissal. 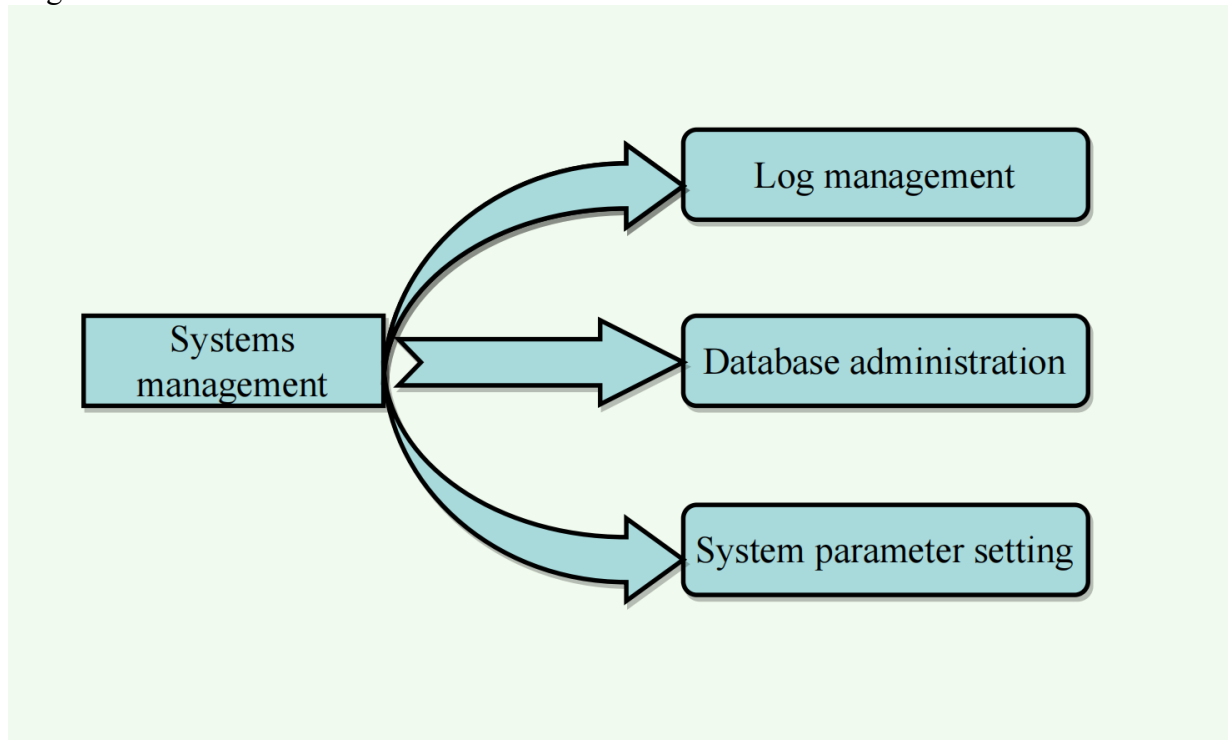


Figure 2 Structure diagram of system management function module
