# Security Risk Assessment of National Police Cooperation from the Perspective of Global Security Governance

Therefore, this paper adopts the definition of behavior class and defines the national police cooperation as a law enforcement behavior in which police agencies in different countries provide mutual assistance and cooperation according to relevant legal documents, practices or the principle of reciprocity[4].

In a broad sense, "cooperation involving police departments can be regarded as national police cooperation." Therefore, the national police cooperation in this paper includes international law enforcement cooperation and criminal justice cooperation.




Fig.1 Security Risk Assessment Index of National Police Cooperation

A deep understanding of the soft elements of national social economy and politics is helpful to understand the characteristics of risks, thus helping security managers to formulate scientific management plans[8]. The first step of security risk assessment of national police cooperation needs to identify all kinds of potential security risk points in the process of police cooperation. It mainly follows the principle of finding the cause from the result, and gradually refines the causes of the security risk of national police cooperation from the whole to the part according to the branch shape, and then finds out the causal relationship between the security risk dependent variable and the risk point independent variable. The security risk assessment indicators of national police cooperation are shown in Figure 1.

#### 4.1 Innovate the National Police Cooperation Mechanism

For countries with relatively weak relationship foundation, we should enhance mutual understanding and establish a benign relationship foundation by strengthening communication. In the process of cooperation, in order to improve the efficiency of case detection, it is often necessary to learn the laws and languages of each other's countries, which is conducive to establishing friendly partnerships and enhancing mutual trust.

In order to consider establishing a special normalized police communication mechanism to make communication more stable and efficient. We can try to establish a core dialogue mechanism, which includes many cooperative institutions at different levels and in different directions to maximize the effect of the communication mechanism; In addition to the communication mechanism between senior police officers in various countries responsible for specific cooperation matters, we can also consider building an exchange platform for grass-roots law enforcement officers in various countries. Relying on police schools in various countries, police forums are held regularly to select outstanding police officers to exchange experience in law enforcement cooperation, increase mutual understanding, and then cultivate a good relationship foundation.

## 4.3 Optimize the Global Layout of National Police Cooperation in China

The foundation and conditions of China's opening to the outside world have undergone fundamental changes, and the opening layout needs to be improved and even more innovative, as does the global layout of national police cooperation. In the long run, with the development of China and the enhancement of its own strength, China should no longer be confined to participating in various national police cooperation organizations and concluding cooperation agreements or treaties, but should play a leading role, and dare to be the first at critical moments, dare to put forward new ideas and create new mechanisms.

In the short term, China should continue to make efforts to carry out national police cooperation based on the existing international pattern dominated by the West. With the development and strength of China, China should gradually reform and improve the existing international pattern and rules, and establish more fair and just rules for international cooperation with mutual respect and consultation. Make full use of the established Sino-US law enforcement and cyber security dialogue mechanism, take the initiative to contact and talk with the US law enforcement agencies, maintain the momentum of cooperation, try to push bilateral cyber security law enforcement cooperation to a new stage of development, and minimize the negative impact of friction in the economic and trade field.

On the basis of the original bilateral police cooperation, the public security organs should continue to carry out in-depth bilateral police cooperation in various fields with neighboring countries, mobilize the enthusiasm of local public security organs at all levels, and carry out police cooperation in a targeted manner according to local conditions. Guided by the Global Security Governance Initiative, we will vigorously develop and deepen the police cooperation relationship with countries along the Initiative. Wherever the Initiative is implemented, police cooperation will be carried out, and we will strive to achieve full coverage of countries along the Initiative and protect the country's overseas interests.

# 4.4 Establish a Security Risk Early Warning Mechanism for National Police Cooperation




Fig.2 Security Risk Early Warning Mechanism of National Police Cooperation
