# Research on the Integration of Morality and Law Courses and Labor Education in Elementary School

Wang<sup>[5]</sup> proposes that in the teaching practice of labor education in senior high school, the main front of the classroom can be used to innovate the construction of labor knowledge system, so as to realize the effective connection between elementary and middle school labor education.

Nowadays, with China attaching more and more importance to labor education, how to promote the reform and innovation of rural labor education has become a serious problem for both elementary school and ordinary teachers<sup>[6]</sup>. It is of great significance to combine elementary school labor education with morality and law practice teaching organically to improve students' quality, improve their practical ability and improve their practicability. At the same time, the implementation of the policy will be more targeted, especially the "quasi workers" should have a strong comprehensive quality, not only to improve labor consciousness, improve labor consciousness, training employment ability to achieve greater breakthroughs; Through the creation of labor education and morality and law courses practical teaching model, but also to promote the development of students. #### 3. The problems existing in the practice teaching mode of labor education and morality and law courses

### 3.1. The practical teaching concept of labor education and morality and law course lacks human nature

When implementing the practical teaching of "morality and law courses", some teachers ignore the integration with the content of labor education and lack the cultivation of "craftsman spirit", which directly results in the low awareness and ability of students to "strive for perfection".

### 3.2. The practical teaching methods of labor education and morality and law courses lack of integration

This paper makes an in-depth analysis of the problems existing in the practical teaching mode of labor and morality and law work in elementary and secondary schools in China. The main manifestations are the lack of integration and the lack of organic combination.

For example, in labor education, it does not attach importance to combining the labor connotation of the excellent traditional Chinese culture with labor, and does not do enough to educate, guide and serve students. Students have not formed a profound understanding of their own social value, and the education of the Marxist concept of labor is still weak. Labor education and morality and law practice teaching can not be well combined, this is mainly due to the lack of students in the actual work of the concept of labor training, such as students do not want to participate in "volunteer" activities, some elementary school students even feel that "labor is shameful".

### 4. Optimization strategy of practical teaching mode of labor education and morality and law courses

## 4.1. Highlight the human nature of the practical teaching concept of labor education and morality and law course

The main purpose of elementary education is to cultivate specialized talents. In particular, we should organically combine labor education with morality and law course practice teaching, pay attention to the significant improvement of students' theoretical literacy and practical ability, highlight the human nature of labor education and morality and law course practice teaching, increase the investigation and analysis of students, find out the relevant factors that restrict the improvement of students' quality, and vigorously promote the innovation of labor education model.

In the concrete implementation, we should design and organize labor education scientifically and systematically, especially combine morality and law work with labor, correctly handle the relationship between "explicit labor" and "implicit labor education", and pay more attention to carrying out "implicit labor education" through the practice teaching of morality and law courses. We should integrate the "spirit of labor" into morality and law education, strengthen students' awareness of "seeking excellence", and significantly improve their ability to find employment, start businesses and develop.

### 4.2. Strengthen the integration of labor education and morality and law practice teaching methods

The practical teaching of labor and morality and law courses in elementary school is a new kind of educational integration, and we should actively explore the way of moral education with integration, interaction and penetration.

In the concrete implementation, we should not only combine the two organically, but also combine the theory and practice. For example, we should strengthen the labor theory education, and then combine the practical teaching of morality and law courses, so as to make the moral education work more systematic, and cultivate the students' consciousness and ability of combining theory with practice. We should strengthen the combination of labor education and morality and law practice teaching, and introduce Marx's labor concept into labor education, so that students can realize, experience, appreciate and create beauty.

# **4.3.** Promote the coordination between labor education and morality and law course practice teaching mechanism

Labor and morality and law courses are highly practical and involve all aspects. The "collaborative mechanism" between labor and morality and law work should be strengthened to achieve greater breakthroughs.

Elementary schools should actively promote the reform of practical teaching mode of morality and law courses, among which the most important point is to organically combine "morality and law courses" with "morality and law courses", combine labor education with practical teaching of morality and law courses, and establish a cooperative education system. It is necessary to further expand the field of labor education. It is also necessary to strengthen the pertinence and specificity of morality and law course practice teaching, such as guiding students to enhance their ideological, political, cultural, theoretical and other comprehensive qualities in labor practice, so as to improve students' future employment and entrepreneurial ability.

### 4.4. Promote the education carrier diversification of labor education and morality and law courses of practical teaching

Starting from the construction of practical teaching mode of labor and morality and law courses, strengthen the construction of training carrier, so that students' comprehensive quality can be further improved. Therefore, elementary schools should create a favorable environment for practical teaching and vocational skills training, and create more practical carriers on this basis. We should promote the diversification of practical teaching content of labor and morality and law courses, and at the same time give full play to students' subjectivity and create a mechanism for students to participate in labor.

#### **5. Conclusions**

In the current situation that China attaches great importance to students' labor education, we should not only expand the scope of labor education, but also strengthen its comprehensive effect. Therefore, we should focus on the construction of labor and morality and law work of practical teaching, in order to achieve better results. In the concrete implementation, we should fully understand the significance of the practical teaching mode of labor education and morality and law courses, at the same time, we should adhere to the problem-oriented, focus on solving the problems existing in the practical teaching mode of labor education and morality and law courses, and use systematic thinking. Focus on highlighting the concept of education, human nature, strengthen the integration of methods, promote the coordination of mechanisms, promote the diversification of education carriers and other aspects of the work to make greater breakthroughs in the construction of elementary school education mode.
